**A RESOLUTION OF THE BOROUGH OF ABBOTTSTOWN,
ADAMS COUNTY, PENNSYLVANIA, ESTABLISHING APPROVED FEES
FOR THE ZONING PROCESS FOR 2019**

WHEREAS, the Borough of Abbottstown is a political subdivision of the Commonwealth of Pennsylvania; and

WHEREAS, under the authority of section 601 of the Pennsylvania Municipalities Planning Code (MPC), 53 P.S. §10601, Abbottstown has enacted a Zoning Ordinance (Ordinance) to implement its comprehensive plan and to accomplish the purposes of the MPC; and

WHEREAS, under section 1404 of the Ordinance, Abbottstown Borough Council shall, by resolution, create a schedule of fees to be paid to defray the cost of administering and processing applications for zoning and related applications; and

WHEREAS, among other matters, the fees cover the costs of the zoning officer for reviewing applications and related matters and for purposes of determining compliance with the Ordinance; and


WHEREAS, the appointed zoning officer for Abbottstown, PA Municipal Code Alliance, has established a schedule of fees for 2019 (Fee Schedule) for professional fees and out-of-pocket costs; and

WHEREAS, the Fee Schedule (attached hereto as Exhibit A) is reasonable for services provided to Abbottstown Borough in connection with the Ordinance;


NOW, THEREFORE, be it resolved:



In the event that the actual costs incurred by Abbottstown Borough in connection with a hearing before the Zoning Hearing Board or the Abbottstown Borough Council exceeds the fee paid under this schedule, the applicant or appellant shall be billed for those actual costs. Such costs may include notice and advertising costs and necessary administrative overhead connected with the hearing, and shall include half of the appearance fee for the stenographer as authorized by Section 980(7) of the Pennsylvania Municipalities Planning Code (Act 247 of 1968, as reenacted and amended). Such costs shall not include the legal expenses of the Zoning Hearing Board, expenses for engineering, architectural or other technical consultants or expert witness costs.
