Re: Resolution to support HB794 and similar legislation

Greetings from Adams County,

At their regularly scheduled meeting on April 20th, Abbottstown Borough Council will propose and adopt a resolution to support Rep. Torren Ecker's HB794. This is in direct response to actual events that are costing our local volunteer fire departments more in auditing fees due to state regulations, as reported by our fire department at their annual meeting last week. A synopsis of the bill follows. We ask that a placeholder be made for this resolution to be considered by the PSAB Resolution and Policy Steering Committee. Thank you.

HB794 - Further providing for definitions, for registration of charitable organizations, financial reports, fees and failure to file, for registration of professional solicitors, contract and disclosure requirements, bonds, records and books and for administrative enforcement and penalties.

Synopsis: Amending the act of December 19, 1990 (P.L.1200, No.202), entitled "An act providing for the registration and regulation of solicitations by charitable organizations, professional fundraisers and other solicitors; imposing additional powers on the Department of State and the Office of Attorney General; prescribing civil and criminal penalties; and making a repeal," further providing for definitions, for registration of charitable organizations, financial reports, fees and failure to file, for registration of professional solicitors, contract and disclosure requirements, bonds, records and books and for administrative enforcement and penalties.

WHEREAS borough officials learned that there are significantly increased costs to volunteer fire departments in the requirement of more detailed audits when they have utilized a 3rd party provider for supplying supplies such as printed tickets; and

WHEREAS Representative Torren Ecker has presented HB794 to amend the statutes creating these disproportionate unfunded mandates to our volunteers;

NOW, THEREFORE, BE IT RESOLVED that the Council of the Borough of Abbottstown supports HB794 and calls upon the Representatives and Senators in Harrisburg to co-sponsor, support, and pass this much-needed relief to our volunteer organizations.
