A RESOLUTION OF THE BOROUGH OF ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA, AUTHORIZING THE ENTRY INTO AN INTERMUNICIPAL AGREEMENT WITH BERWICK TOWNSHIP FOR SNOWPLOWING/SNOW REMOVAL

WHEREAS, the Pennsylvania Intergovernmental Cooperation Act, 53 Pa. C.S. §2301-§2317 (the "Act"), provides that two or more local governments in the Commonwealth may jointly cooperate in the exercise or in the performance of their respective governmental functions, powers or responsibilities; and

WHEREAS, pursuant to the Act, local governments so cooperating are authorized to enter into any joint agreements as may be deemed appropriate for those purposes; and

WHEREAS, pursuant to the Act, the governing bodies may only enter into an intergovernmental cooperation agreement upon the passage of a Resolution; and

WHEREAS, the Borough Council of the Borough of Abbottstown wishes to enter into an Intermunicipal Agreement with Berwick Township to provide for snowplowing/snow removal within the Borough, a copy of the said Intermunicipal Agreement is attached hereto and made a part hereof.

WHEREAS, Berwick and Abbottstown are represented by same Solicitor, who disclosed the potential conflict of interest, and Berwick and Abbottstown each waived the conflict of interest as to the preparation of the Intermunicipal Agreement; and

NOW THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Abbottstown Adams County, Pennsylvania is authorized to enter into the said Intermunicipal Agreement with Berwick Township.
