## A RESOLUTION OF THE BOROUGH OF ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA, ASSIGNING STREET ADDRESSES FOR CERTAIN PROPERTIES WITHIN THE BOROUGH.

## WHEREAS;

Boroughs are the legal authority under the Pennsylvania Municipal Codes via the Borough Code (PA Consolidated Statutes Title 8 of 2018) to assign or amend street addresses within the municipality, and;

Houses are numbered in a uniform fashion to ensure that 911 responders (fire, police, or ambulance) may quickly locate an address when necessary, and;

J. A. Myers, owner of record of the properties known as Sutton Run Estates, Abbottstown, has requested an address assignment for the newly proposed properties, and;

Members of the local and county emergency services were consulted for any best practices to these assignments, and the numbers proposed are in accordance with spacing and numbering recommendations which resulted from said consultations, which will help improve future response time for first responders to said parcels;

**NOW, THEREFORE, BE IT RESOLVED** that the Abbottstown Borough Council hereby authorizes the assignments listed on the attached exhibit (A) for property numbers along Meckley Run, Lillich Drive, Peterson Lane, and Alwine Way. Developer is to ensure proper identification of each parcel by affixing the addresses at the main entrances of the properties so they can be clearly seen from the road by emergency personnel. Borough staff is instructed to notify the Abbottstown Post Office, the property owner, United Hook and Ladder No. 33, Adams Regional EMS, and the Adams County Tax Services Department of said changes.
