# AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF ABBOTTSTOWN, ADAMS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE No. 2019-04, AS CODIFIED IN CHAPTER 197 OF THE CODE OF THE BOROUGH OF ABBOTTSTOWN RELATING TO GENERAL PARKING REGULATIONS ORDINANCE No. 2024-03

The Council of the Borough of Abbottstown, Adams County, Pennsylvania, enacts and ordains:

### **SECTION 1**

Ordinance 2019-04 is hereby amended to include:

- § 402. Parking Prohibited at all Times in Certain Locations.
  - 1. The following acts shall be unlawful within the Borough as follows:
    - U. No vehicle shall be parked on any curb or place along any part of West Water Street from North Queen Street to North Saint James Street at any time.
    - V. No vehicle shall be parked on any curb or place along any part of West Water Street from Pleasant Street to Abbott Street at any time.
    - W. No vehicle shall be parked on any curb or place along any part of North Clinton Alley from West Water Street to High Street at any time.
    - X. No vehicle shall be parked on any curb or place along any part of Pleasant Street from West King Street to Industrial Entrance Road/Parking lot at any time.
    - Y. No vehicle shall be parked on any curb or place along any part of Jacob Alley from West Fleet Street to West Water Street at any time.
    - Z. No vehicle shall be parked on any curb or place along any part of Saint James Street from West Water Street to High Street at any time.
    - AA. No vehicle shall be parked on any curb or place along any part of High Street from Pleasant Street to Abbott Street at any time.
    - BB. No vehicle shall be parked on any curb or place along any part of West Fleet Street from South Queen Street to Sutton Road at any time.
    - CC. No vehicle shall be parked on any curb or place along any part of West Fleet Street from Sutton Road to Jackson Street at any time.

- DD. No vehicle shall be parked on any curb or place along any part of South Clinton Alley from West Fleet Street to West King Street at any time.
- EE. No vehicle shall be parked on any curb or place along any part of East Water Street from Country Club Road to Lower Alley at any time.
- FF. No vehicle shall be parked on any curb or place along any part of North German Street from East King Street to East Water Street at any time.
- GG. No vehicle shall be parked on any curb or place along any part of Lower Alley from East Fleet Street to East Water Street at any time.
- HH. No vehicle shall be parked on any curb or place along any part of North Country Club Road from East King Street to East Water Street at any time.
- II. No vehicle shall be parked on any curb or place along any part of East Fleet Street from Country Club Road to South German Street at any time.
- JJ. No vehicle shall be parked on any curb or place along any part of South Country Club Road from East King Street to Spicer Drive at any time.
- KK. No vehicle shall be parked on any curb or place along any part of Dale Alley from Pleasant Street heading west to dead end at any time.
- LL. No vehicle shall be parked on any curb or place along any part of Posey Place from Dale Alley heading west to dead end/end of Borough line at any time.
- Chapter 183, Article II, § 183-19 of the Code of the Borough of Abbottstown is hereby amended with the addition of the verbiage as follows:
  - § 197-25 Parking prohibited at all times in certain locations.
    - A. The following acts shall be unlawful within the Borough as follows:
      - (21) No vehicle shall be parked on any curb or place along any part of West Water Street from North Queen Street to North Saint James Street at any time.
      - (22) No vehicle shall be parked on any curb or place along any part of West Water Street from Pleasant Street to Abbott Street at any time.

- (23) No vehicle shall be parked on any curb or place along any part of North Clinton Alley from West Water Street to High Street at any time.
- (24) No vehicle shall be parked on any curb or place along any part of Pleasant Street from West King Street to Industrial Entrance Road/Parking lot at any time.
- (25) No vehicle shall be parked on any curb or place along any part of Jacob Alley from West Fleet Street to West Water Street at any time.
- (26) No vehicle shall be parked on any curb or place along any part of High Street from Pleasant Street to Abbott Street at any time.
- (27) No vehicle shall be parked on any curb or place along any part of Saint James Street from West Water Street to High Street at any time.
- (28) No vehicle shall be parked on any curb or place along any part of West Fleet Street from South Queen Street to Sutton Road at any time.
- (29) No vehicle shall be parked on any curb or place along any part of West Fleet Street from Sutton Road to Jackson Street at any time.
- (30) No vehicle shall be parked on any curb or place along any part of South Clinton Alley from West Fleet Street to West King Street at any time.
- (31) No vehicle shall be parked on any curb or place along any part of East Water Street from Country Club Road to Lower Alley at any time.
- (32) No vehicle shall be parked on any curb or place along any part of North German Street from East King Street to East Water Street at any time.
- (33) No vehicle shall be parked on any curb or place along any part of Lower Alley from East Fleet Street to East Water Street at any time.
- (34) No vehicle shall be parked on any curb or place along any part of North Country Club Road from East King Street to East Water Street at any time.
- (35) No vehicle shall be parked on any curb or place along any part of East Fleet Street from Country Club Road to South German Street at any time.
- (36) No vehicle shall be parked on any curb or place along any part of South Country Club Road from East King Street to Spicer Drive at any time.

- (37) No vehicle shall be parked on any curb or place along any part of Dale Alley from Pleasant Street heading west to dead end at any time.
- (38) No vehicle shall be parked on any curb or place along any part of Posey Place from Dale Alley heading west to dead end/end of Borough line at any time.

## **SECTION 2**

All Ordinances or Resolutions or parts of Ordinances or Resolutions which are inconsistent herewith are hereby repealed to the extent that the same are inconsistent with the terms of this Ordinance. Nothing in this legislation hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired, or affected by this Ordinance.

# **SECTION 3**

If any section, subsection, sentence, clause, or phrase of this Ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The Borough of Abbottstown hereby declares that it would have passed this Ordinance, and each section, subsection, clause, or phrase thereof, irrespective of that fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional.

## **SECTION 4**

The Code of the Borough of Abbottstown, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the Code of the Borough of Abbottstown, as amended, upon enactment.

# **SECTION 5**

This Ordinance shall be effective immediately following its legal enactment.

Pleasant Street from West King Street to Industrial Entrance Road/Parking Lot; E. Jacob Alley from West Fleet Street to West Water Street; F. Saint James Street from West Water Street to High Street; G. West Fleet Street from South Queen Street to Sutton Road; H. High Street from Pleasant Street to Abbott Street; I. West Fleet Street from Sutton Road to Jackson Street; J. South Clinton Alley from West Fleet Street to West King Street: K. East Water Street from Country Club Road to Lower Alley: L. North German Street from East King Street to East Water Street; M. Lower Alley from East Fleet Street to East Water Street; N. North County Club Road from East King Street to East Water Street; O. East Fleet Street from County Club Road to South German Street; P. South County Club Road from East King Street to Spicer Drive; Q. Dale Alley from Pleasant Street heading west to the dead end; and R. Posey Place from Dale Alley heading west to the dead end/end of Borough line.
